### REGISTRATION INFORMATION

The form on the next page should be copied, completed, and submitted by one member of each partnership. All sections on the form should be completed so that they are legible. The entry form and a check or money order (made out to ACBL DISTRICT 12) should be mailed as per the instructions on the form. A meal will be provided between sessions to facilitate a timely start to the second session; the cost of that meal is included in the entry fee.

### THE FOLLOWING POLICIES APPLY TO ENTRIES TO THE DISTRICT FINALS:

We understand that the District is not responsible for mailed entries not received on a timely basis. Pairs who do not pre-register will pay the walk-in registration rate of \$96. We understand that, after pre-registering, we may withdraw from the event prior to the day of play and that the amount refunded will be commensurate with the amount of notice given for the withdrawal.

If given before September 17, only a \$10 administrative fee will be withheld; if not given until September 17 or thereafter, a \$25 administrative fee will be withheld. If there is withdrawal on the day of the event or a failure to appear, the entire entry fee is subject to forfeit. We understand that, in the event that a member of this partnership is found to be ineligible to participate in the event at the time of registration at the playing site, the entire entry fee is subject to forfeit.

### CERTIFICATION

By entering this event, each of us certify:

1. We meet the MP restrictions for our flight based on the June 2017 ACBL Masterpoint cycle (based on data from May 7, 2017).
2. We meet the ACBL residency requirements to play in District 12.
3. We are members in good standing of the ACBL at all stages of this event.
